Both days Trial 1 and Trial 2 will run concurrently in the **following order** Novice T1, T2; Advanced T1, T2; Excellent T1, T2; Master T1, T2

ENTRY AND WAIT LIST INFORMATION

Exhibitors will receive an email **confirmation** of their entries being received. Exhibitors will also receive an email confirmation of their inclusion on the Wait List. After the entry period closes, the Trial Secretary will send a final confirmation with classes entered.

The Judging Schedule will be determined after the trial closes. The Judging Schedule will be provided by email to all exhibitors with confirmed entries or who are on the Wait List as soon as it is available.

A wait list will be offered for these trials to fill openings created by entries that are withdrawn after the trial closes or the registration limit is reached. Entries received after the registration limit is reached will automatically be added to the Waiting List until that limit is reached as of 9:00 PM on the day on which they were received until that limit is reached. We will maintain a waitlist of 20 entries.

Wait list refunds – if a withdrawn entry is replaced by a wait listed entry, the withdrawn entry will be entitled to a full refund. Any wait listed entry that does not move off the wait list into the trial will be entitled to a full refund. Withdrawn entries that are not replaced by a wait listed entry will not receive a refund.

A/B SECTIONS

The A/B Sections – The Novice A class is for beginners. Those dogs who have earned a title in that element from the AKC or from another organization and those handlers who have worked as professional detection dog handlers must enter the B section. The exhibitor is fully responsible for entering the dog in the correct class(es)/divisions. Failure to do so will result in the cancellation of qualifying scores.

CLASS INFORMATION

Levels – Dogs that have previously earned the same or higher level AKC Scent Work titles may enter lower-level classes. Dogs may enter up to two (2) difficulty levels for which they are eligible in each element, in each trial.

Class Transfers – The Trial Secretary will accept requests for move-ups or other class transfers after entries have closed for these trials. The deadline is Tuesday prior to the trial.

At the trial, any request for a **move-up** must be in writing and presented to the trial Secretary at least 30 minutes prior to the start of the trial, unless a dogs earns its title (3rd leg) in trial 1. If that is the case, the exhibitor should notify the judge they will be moving up and complete a "move up form" immediately for the Trial Secretary. The Trial Secretary will have forms available on site for transfer requests.

Run Order – The Run Order will be determined after entries have closed and will be sent by email to entrants who have provided a legible email address.

The Class Order will be Novice T1, T2; Advanced T1, T2; Excellent T1, T2; Master T1, T2. Trial 1 and 2 will run concurrently.

WARM UP AREA

A warm-up area will be available consisting of one labeled container per target odor being used in the trial on that day and may also consist of blank containers. Exhibitors should limit their warm-up to two minutes or less. The warm-up area is to be used exclusively for warming up the handler-dog team prior their run. The warm-up area is not for training or relieving of the dog.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Event Committee.

Withdrawals – For females in season pulled after closing, the owner/handler must submit a written or emailed request to receive a refund of entry fees. For dogs pulled after closing due to injury or other medical condition, the owner/handler must submit a written or emailed statement from their vet as to the dog's condition to receive a refund of entry fees.

For dogs pulled after closing due to a judge assignment change, the owner/handler must submit a written or emailed request indicating the class of the entry and stating that the withdrawal is due to a judge assignment change to receive a refund of entry fees. Any such withdrawal notifications must be submitted to the Trial Secretary in writing no later than one half hour prior to the start of the first class on the first day the dog is entered in the trial to be eligible for a refund of entry fees. The Trial Secretary will have forms available on site for withdrawal requests. See Waiting List refunds above for additional refund information.

Timing of Refunds – Exhibitors who are eligible for a refund of entry fees, wait listed entry fees, or any other amount for any reason are advised that it may take up to three weeks after the date(s) of the trial weekend to receive their refund.

CHECK IN AND HANDLER'S BRIEFING

Exhibitors must **check in** for each dog entered in each trial. Exhibitors may begin check in at 8:15 AM each day and are expected to complete check in by 8:45 AM. Exhibitors who are unable to check in by 8:45 AM should communicate with the Trial Secretary before that time so that they are not counted as absent and have their entries replaced by entries on the

Exhibitors who are unable to attend notify the Trial Secretary as soon as possible so that their entries can be replaced by entries on the Wait List.

Exhibitors will pick up their **armband number** at check in. A copy of the run order will be available at the check in table.

First Handler's Briefing will take place at 9:00 AM each day with the first dog in the class to run after the briefing.

The Handler's Briefing will take place in view of the search area(s) prior to the start of each class. In the search area(s), the number of hides, the maximum height of hides, and maximum time for the search. **No dogs** are to be present during the Handler's Briefing.

TRIAL SITE INFORMATION

Bratty Paws Dog Plex 2551 Taylor Road, Punta Gorda, FL 33950

Trial Site – It is not appropriate to scout the trial location prior to the trial date. Many search locations are real-life environments, and such visits may risk the host losing the opportunity to use the location in the future.

Spectator Area will be available at this trial. No one outside the search area may assist the handler or disclose the location of the hide. Spectators who intentionally or unintentionally give aid to a team may be asked to leave the area by the judge. Spectators are forbidden to discuss details of the search with handlers who have not run.

Crating space will be available indoors in air conditioning. Dogs should only be crated in designated areas and on a tarp.

Crates may be left overnight; however, the Greater Port Charlotte Agility Club will not be responsible for any lost or damaged items left at the trial site.

No dogs may be left overnight on the grounds of the trial site.

PLEASE NOTE:

- Barking Dogs Any exhibitor with a dog barking excessively will be asked to crate the dog from their vehicle. If refused, the exhibitor will be asked to leave the trial and forfeit their fees.
- Exhibitors alone are responsible for the behavior of their dogs. Any exhibitor whose dog(s) create
 unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion
 of the Trial Committee, be asked to leave the trial site. In such cases, no refund of any fees will be
 made.
- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be
 excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this
 requirement. Cleaning supplies and disposal sites will be available at various locations around the show
 grounds.
- ANY dog that soils on the artificial turf will be charged a \$20 cleaning fee. The crating area will be marked off and will have tarps in an attempt to avoid accidents.

The GPCAC, the trial secretary, their agents, etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors or their dogs or property. Nor do the above mentioned assume responsibility for injury to children not under control of their parents or guardians.

If it is necessary to rescue a dog from a parked car on the trial grounds, neither GCCAC nor Bratty Paws Dog Plex will be responsible or liable for any damage to the vehicle involved.

SEARCH AREAS AND WEATHER CONDITIONS

Some classes will take place indoors in air conditioning on matted or tiled surfaces; some will take place in adjacent areas outdoors. The Judging Schedule will indicate which classes are to be run outdoors. Outdoor searches will be conducted rain or shine unless dangerous conditions are present (such as lightning or clouding). Comfortable footwear and water-resistant clothing are recommended.

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs, six (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, have Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), are enrolled in the AKC Canine Partners program, or are recorded in the Foundation Stock Service (FSS).

Wherever the word "dog" is used herein it includes both sexes.

Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, the dog displays no sign of physical discomfort and can safely complete the search. Deaf and blind dogs are allowed to enter. Females in season may not participate, aggressive dogs, or dogs suffering from an injury, or illness which may affect the dog's physical or mental performance may not participate. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four (4) months of age are strictly prohibited from the trial grounds.

HANDLING MORE THAN ONE DOG: Handlers may not handle more than one dog in each class. Multiple dogs owned by the same person(s) may be entered in the same class, provided they are run by different handlers.
